Invitation letter from the Maritime Agency.	
An invitation from the maritime agency of the Member State stating the location / seaport where the sailor will embark. The invitation needs to be signed and contain the seal / stamp of the agency and include the following data:	
 name and family name of the seafarer place and date of birth, passport number, seaman's book number date of issue, period of validity position of the seafarer on the boat (if there are many seafarers their information can be included in a list signed and sealed, as an annex of the invitation letter) date and airport of entry into the territory of the Member States name of the boat port of boarding duration of the contract itinerary that the seafarer will follow to arrive in the Member State of destination 	
The maritime agency from the Member State must indicate the following in their letter of invitation to the South African Agency it collaborates with:	
- company name - registration and VAT number - physical and postal address	
The above requirements apply to any South African based company which will be in charge of presenting the visa application or which will act on behalf of the seafarer once the applicant arrives in the Member State until embarkation takes place.	
If the application is presented by a maritime agency of South Africa: letter of invitation of the South African agency that includes a list of the seafarer(s), in which is stated their employment on the ship.	
Please note that the Embassy will consider your socioeconomic situation in your home country or in your country of residence if not the same. It is your responsibility to submit any other documents related to personal ties in South Africa, such as marriage certificate, title deeds or lease agreements.	

Information for the applicant on terms and conditions:

- The application must be submitted **15 days before the start of the intended visit**. Applications can also be submitted up to 6 months before the intended travel.
- Applications shall be decided on within 15 calendar days of the date of the lodging of an application which is
 admissible in accordance with Article 10 and Article 19. That period may be extended up to a maximum of 45
 calendar days in individual cases, notably when further examination of the application is deemed necessary.
 Please note that the days are counted from when the Embassy has received the application and not when the
 application was lodged at VFS Global!
- All submitted documents must be in English or in Swedish.
- Further information or documentary evidence in support of your application may be required as well as an interview. It is therefore important that you provide accurate contact details.
